

BY-LAW NO. 525-97

**BEING A BY-LAW OF THE TOWN OF
FOX CREEK, IN THE PROVINCE OF
ALBERTA TO AMEND BY-LAW 341-
88, AND SUBSEQUENT AMENDING
BYLAWS 352-89, 386-91, 409-92, AND
431-93, BEING BYLAWS TO PROVIDE
FOR THE LICENSING AND
REGULATIONS OF CERTAIN
BUSINESSES, CALLINGS, TRADERS,
OCCUPATION, AND EMPLOYMENT.**

WHEREAS Council of the Town of Fox Creek, in the Province of Alberta, under the authority of the Municipal Government Act, being Chapter M-26.1 of the Revised Statutes of Alberta, 1984, and amendments thereto, may pass bylaws for the purpose of regulating and controlling business being carried on within the Town of Fox Creek in the Province of Alberta; and

WHEREAS the Council of the Town of Fox Creek has established a By-law for the purpose of regulating and controlling business being carried out within the Town of Fox Creek; and,

WHEREAS the Council of the Town of Fox Creek deems it necessary to amend By-law Number 341-88, and all subsequent amending By-laws aforementioned;


NOW THEREFORE, THE MUNICIPAL COUNCIL OF THE TOWN OF FOX CREEK, IN THE PROVINCE OF ALBERTA, DULY ASSEMBLED, ENACTS AS FOLLOWS:

1. That **Section 7 LICENSE FEE** be amended as follows:
 - 7 (b) (i) (A) The annual license fee for non-resident businesses other than contractors or peddlers shall be \$250.00 per annum;
 - 7 (B) (I) (B) The fee for a non-resident contractors license shall be \$250.00 per annum; or
 - \$200.00 per project where the value of the contract or work to be done exceeds \$10,000.00; or
 - \$125.00 per project where the value of the contract or work to be done is \$10,000.00 or less.
 - 7 (b) (I) (C) The fee for all peddlers shall be \$250.00 per annum; or \$100.00 per week; or \$25.00 per day
 - 7(ii) The license fee for all **MAJOR** home occupation businesses shall be \$120.00 per annum, and all **MINOR** home occupation businesses shall be \$100.00 per annum;

- 7 (iii) The license fee for all resident businesses including resident contractor businesses, but excluding home occupation businesses shall be \$65.00 per annum for one business per license, and \$75.00 for resident businesses with multiple businesses under one license;
- 7 (v) The license fee for all resident service businesses listed shall be \$75.00 per annum: Banks and Financial Institutes, Utility Companies, Cable Companies, apartment buildings and mobile home parks;
2. That Section 18 Penalty shall be amended as follows:
- 18 (c) Quarterly penalties shall be automatically applied to all outstanding business license accounts in the order of:

| December 31 | \$100.00 year end. |
- New accounts set up and pro-rated shall have the penalty applied every three months from the starting date.
3. THIS BY-LAW SHALL COME INTO EFFECT ON JANUARY 1, 1998.
