

THE CORPORATION OF THE TOWN OF FOX CREEK, ALBERTA

BY-LAW 673-2008

2008 ASSESSMENT REVIEW BOARD

A By-law of the Municipal Corporation of the Town of Fox Creek, in the Province of Alberta for the establishment of an Assessment Review Board for 2008 pursuant to the provisions of the Municipal Government Act, Chapter M26.

WHEREAS the Council of the Corporation of the Town of Fox Creek has authority to pass a by-law for the establishment of an Assessment Review Board pursuant to section 454(1)(2)(a) of the Municipal Government Act, Chapter M26,

AND WHEREAS Council deems it necessary to establish an Assessment Review Board composed of three members and an alternate,

AND WHEREAS Council must appoint a Clerk of the assessment review board pursuant to section 455(1) of the Municipal Government Act, Chapter M26,

NOW THEREFORE PURSUANT to the provisions of the Municipal Government Act, Chapter M26, the Council of the Town of Fox Creek, Alberta, In regular session duly assembled, enacts as follows:

SEVERABILITY

If any provision of this by-law is declared invalid because of any word, phrase, clause, sentence, paragraph or section of this by-law or any documents which form part of this by-law or an application thereof to any person or circumstance is declared invalid, the remaining provisions shall not be affected thereby, but shall remain in force.

SECTION 1 – SHORT TITLE

This By-law may be cited as the "2008 Assessment Review Board By-law".

SECTION 2 – APPOINTMENTS

- 2.1 That the Town of Fox Creek hereby establishes an Assessment Review Board for the 2007 Assessment for the 2008 tax year;
- 2.2 That the Assessment Review Board consist of three (3) members who shall hold office for 2008 and shall hear all complaints regarding the 2007 assessment;
- 2.3 That the following individuals be appointed to sit on the Assessment Review Board:
 - a) Brenda Burrige
 - b) Irvine Bignell
 - c) Sheila Beloin

Alternate:

- d) Jim Ahn
 - e) Mark Petch
- 2.4 That the Members of the Assessment Review Board shall choose and appoint from their members a Chairperson of the Assessment Review Board;

- 2.5 That Cindy Nielson be appointed as the Clerk of the Assessment Review Board;
- 2.6 That the Chairperson of the Assessment Review Board be authorized to fill vacancies that may occur on the Assessment Review Board;
- 2.7 That in the event of a vacancy of the Chairmanship, the Assessment Review Board be authorized to choose and appoint one of its members as the Chairperson;
- 2.8 That the Chairperson of the Assessment Review Board be authorized to call for the sitting of the Assessment Review Board for the purpose of hearing complaints.

SECTION 3 – EFFECTIVE DATE

This By-law shall come into effect the date upon third and final reading.

READ A SECOND TIME this 25th day of August, 2008


Moved and passed unanimously that the "2008 Assessment Review Board By-law", be presented for third and final reading.
