

BY-LAW NO. 337-88

BEING A BY-LAW OF THE TOWN OF FOX CREEK, IN THE PROVINCE OF ALBERTA TO AMEND BY-LAW NO. 67 BEING A BY-LAW TO ESTABLISH AND REGULATE THE COLLECTION, REMOVAL AND DISPOSAL OF GARBAGE, REFUSE AND ASHES.

WHEREAS the Town of Fox Creek deems it desirable to amend By-law No. 67 being a By-law to establish and regulate the collection, removal and disposal of garbage, refuse and ashes; and

WHEREAS the Town of Fox Creek may pass by-laws to regulate the collection, removal and disposal of garbage pursuant to the Section 199 of the Municipal Government Act, R.S.A., 1980, Chapter M-26, as amended;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE TOWN OF FOX CREEK DULY ASSEMBLED ENACTS AS FOLLOWS:

1. that Section 9(a) of By-law No. 67 be amended by substituting this section with the following:

"Any person who violates the provisions of this By-law or amendments thereto, or dumps any waste or materials, other than where indicated, shall, on summary convictions thereof before a Magistrate or a Justice of the Peace, be liable to a fine of not less than \$100.00 and not more than \$500.00, plus costs, and in default of payment of the fine and costs, shall be liable to imprisonment for a period not exceeding sixty (60) days."

2. that Section 7 of By-law No. 67 be amended by adding under Section 7 immediately following subsection (a) the following:

"(b) All garbage shall be hauled to the Town Waste Disposal Grounds and shall be dumped where dumping signs indicate;

(c) No person shall ignite or allow to burn any materials on the Town Waste Disposal Grounds except when authorized to do so by a duly authorized officer of the town; and

(d) No person shall trespass upon the Town Waste Disposal Grounds except during authorized hours of public access to the site and as posted at the site without authority from a duly authorized officer of the town."

3. that every person, firm or corporation that disposes of its refuse at the Town of Fox Creek's Waste Disposal Grounds shall be subject to a Garbage Disposal Fee. For persons, firms or corporations that receive collection and disposal services from the Town of Fox Creek, this fee shall be deemed to be included in the monthly fee charged by the town. For every person, firm or corporation that contracts with a third party or hauls their own refuse, the following shall apply: Each customer shall be assessed on an annual basis (payable in 12 equal payments) an amount based on the estimate of the Secretary-Treasurer, provided that in the event a customer believes he has been incorrectly assessed, he may appeal his assessment during the

month of January of the subsequent calendar year and shall supply documentation to support his appeal. The Unit Rate shall be \$0.45 per cubic yard.

4. that this By-law shall come into force on the final passing thereof.


