

BY-LAW NUMBER 200-77

A BY-LAW FOR THE NEW TOWN OF FOX CREEK FOR
THE PURPOSE OF ENTERING INTO A PREVENTIVE
SOCIAL SERVICES PROGRAM WITH THE TOWN OF
WHITECOURT.

WHEREAS, the Board of Administrators feels that a Preventive
Social Services Program would be of benefit to the Town at
large, and,

WHEREAS, the Board of Administrators feels that the costs of
supporting such a program are too great for the Town alone,
and,

WHEREAS, the Provincial Government has made money available
to assist a regional Directors Program for the Town of
Whitecourt, the New Town of Fox Creek, and I.D. #15,

NOW THEREFORE, the Board of Administrators duly assembled does
enact the following:

THAT, an agreement be entered into with Whitecourt to implement
a Preventive Social Services Director's Program, and

THAT, until the agreement is terminated by either party, its
contents shall be honored by the Board of Administrators of the
New Town of Fox Creek, and


THAT, the agreement shall become Schedule 'A' of this by-law,
and

THAT, this by-law becomes law on the day of its passing.

READ a FIRST time this 11 day of January A.D. 1977.

READ a SECOND time this 11 day of January A.D. 1977.

READ a THIRD and FINAL time this 11 day of January A.D. 1977.

This Agreement made this 11th day of January, 1977.

BETWEEN: The Town of Whitecourt,
P.O. Box 509,
WHITECOURT, Alberta

hereinafter referred to as "Whitecourt"

AND The New Town of Fox Creek,
P.O. Box 149,
FOX CREEK, Alberta

hereinafter referred to as "Fox Creek".

WHEREAS, The Preventive Social Services Act provides the Minister of Social Services and Community Health with authority to encourage and subsidize programs aimed at preventing social problems;

AND WHEREAS, Fox Creek and Whitecourt have agreed to share the cost of a Director's Project as the initial step to commencement of Preventive Social Services in the two (2) centres;

AND WHEREAS, both Fox Creek and Whitecourt have duly passed the necessary by-law authorizing the entering into of Agreements, and operation of, a Preventive Social Services Program.

NOW THEREFORE, FOX CREEK AND WHITECOURT AGREE AS FOLLOWS:

- (1) That this Agreement has applicability only to the Director's Project.
- (2) That the Project be the responsibility of a Committee comprised of Two (2) representatives from each centre, and one (1) representative from Improvement District #15.
- (3) That the costs of operation of the Project will be shared on a per capita basis including the two (2) centres party this Agreement and Improvement District #15, with census taken annually by all participating bodies. The last preceding year's census to be used for calculation purposes.
- (4) That Whitecourt provide office space, stationery and supplies, equipment, furniture and stenographical assistance as may be required by the Director and approved by the Director's Committee, with all costs included in the provision being subject to cost sharing as described in Clause (3) above.
- (5) That each of the parties to this Agreement shall receive for consideration and approval, a budget covering the operations of the Project for the next succeeding year, such budget to be submitted for approval in due time to allow Provincial approval.
- (6) That Whitecourt enter into an Agreement, on behalf of the parties to this Agreement, with the Minister of Social Services and Community Health under the provisions of the Preventive Social Services Act.
- (7) That this Agreement may be terminated on the 31st day of March in any year by any party hereto giving notice in writing to the other party on or before the 30th day of September in the preceding year.

- (8) That the Director's Committee shall elect a Chairperson and Recording Secretary, from its representation, shall record minutes of each duly constituted meeting of the Committee, and shall be responsible to the participating bodies for the effective employment of the Director.
- (9) That Whitecourt will act as the funding authority for the Project, and Fox Creek will remit its share of the Project costs upon receipt of billing from Whitecourt.
- (10) That the time spent by the Director in assisting and advising the Local Advisory Committees in the two (2) centres will be generally in proportion to the population of the two centres.
- (11) That Fox Creek and Whitecourt will individually appoint the person to whom the Director will report, and to whom the Director will be responsible during such times as the Director is assisting and advising to various and individual projects within the two (2) centres.
- (12) That any project (other than the Director's Project) pursuant to the provisions of The Preventive Social Services Act will be applied for, funded and controlled by the individual centre sponsoring the project.
- (13) That this Agreement shall be effective on and from the date of execution under seal by the parties hereto.
