**Accommodation Unit:**

Defined as “any tent, tent- trailer, camper, camping trailer, motor home or other form of moveable temporary lodging, and includes any automobile when used for lodging/ camping purposes.”

**Rules of Stay for RV Campground**

- Registration envelopes must be filled out with information and payment once campers arrive at the campground
- Quiet hours from 11:00 p.m. to 7:00 a.m.
- Use of motorized all- terrain and related vehicles prohibited inside the park
- Alcohol consumption prohibited outside of registered campsite
- Pets must be kept on a leash
- Campsites must not have temporary structures and must be free of clutter
- It is absolutely prohibited to cut trees around the campsites- doing so will result in permanent expulsion from the campground

**How to Pay**

- Campground kiosk using envelopes provided; cheques preferred when using this payment method.
- Town of Fox Creek Town Office using drop slot with envelopes from kiosks or register at front desk. Please have campsite number ready.

**Registration Fees**

- Please pay fees as posted at campgrounds. Fees apply to individual units, rather than per campsite. The only exception to this rule is a child’s tent, which doesn’t require double fee payment.
- Each unit must register separately, with separate envelopes.

**The Fox Creek RV Campground is maintained and managed by the Town of Fox Creek.**  
**The Town reserves the right to refuse and/ or evict occupants of this campground.**

## **Fox Creek RV Campground Fees**

**Effective October 1<sup>st</sup>, 2008**

Serviced Sites (Sites 1 – 17, 31 – 33):

- \$25/ 24 hour period
- \$20/ 24 hour period (**senior rate**)

Un- serviced Sites (Sites 19 – 25):

- \$18/ 24 hour period
- \$15/ 24 hour period (**senior rate**)

## **Fees and Charges By-Law for Non- Payment of Campground Fees**

- \$25/ **day** plus campground fees
- \$150/ **week** plus campground fees
- Non- payment longer than one week will result in removal of all property on campsite, requiring impound fees as well as campground fees and by-law fine.

**Effective October 1<sup>st</sup>, 2008**

Un-serviced Sites (all sites):

- \$18/ 24 hour period
- \$15/ 24 hour period (**senior rate**)
- **Day Use: \$100/ day + \$100 security deposit**

**\*GST included in prices**

**Seniors: 60+**

Please note that sites are rustic.

**Group Use Area** rental includes use of picnic shelter and BBQ, horseshoe pits, gated grassed area for camping (up to 20 campers), picnic tables, water well, fire pits and outhouse. To book the Group Use Area, please contact the Town Office (780) 622 – 3896.

Reservations are required for “Group Use Area” at Iosegun Lake Campground; however please note that **no reservations are taken** for regular sites.

**Fees and Charges By-Law for Non- Payment of Campground Fees**

- \$25/ **day** plus campground fees
- \$150/ **week** plus campground fees
- Non- payment longer than one week will result in removal of all property on campsite, requiring a payment of impounds fees as well as campground fees and by-law fine.
