b) Town Protection- Wildfire Les Paul, Fire Chief

Les Paul came to Council to show his appreciation for all the help his department received during the recent wildfire that started a short distance outside of Fox Creek May 15, 2016 and kept the Town on alert until the fire was reported to be 95% contained May 19, 2016.

Les wanted to thank everyone for the outstanding combined effort that everyone put in. The list of those that he wished to thank is the Town Administration for the administrative work that was executed, two of his firemen that left school and one missed writing his steam ticket to be in the Town to assist with the firefighting efforts, all of the local firemen that took endless hours away from their families and allowed the use of their personal trucks and trailers for moving equipment, the wives and families of the firemen that were very supportive as well as the employers of the firemen, Freson Bros., Fox Creek Sales and Rentals, UFA, Rockwater, WD Towing, Rival, 3 Boys, Marnevic, Devonian, Acklands, Freelance Signs, Chinook Air, Alberta Health Services, MD of Smoky River Fire Department, Peace River Fire Department, High Level Fire Department, MD of Greenview Fire Department, Valleyview Fire Department, Whitecourt Fire Department, Grande Cache Fire Department, County of Northern Sunrise Fire Department and Ralcomm.

All the fire departments worked hard keeping the fire under control, evacuating residence from the Little Smoky area, and doing structural assessments on properties in the event that there was a need to fight fires in a residence's yard.

On Thursday May 12, 2016 Councillor Hailes attended a meeting with representatives from Alberta Energy Regulators, Pembina and Newalta.

Councillor Burridge

Councillor Burridge attended the meeting with the MD of Greenview on May 10, 2016 in Fox Creek. The meeting was very productive. On May 11, 2016 Councillor Burridge went to Little Smoky for part three of a meeting with Alberta Energy Regulators and the MD of Greenview. On May 12 and 13, 2016 Councillor Burridge was in Whitecourt for a meeting with Enbridge. Enbridge has requested to continue the three year extension of the Northern Gateway oil pipeline.

Councillor Thompson

Councillor Thompson attended a meeting between the MD of Greenview Council and the Town of Fox Creek Council on May 10, 2016, on May 11, 2016 Councillor Thompson was in Little Smoky to attend part three of the meeting between representatives of Alberta Energy Regulator, MD of Greenview Council and Town of Fox Creek Council, then May 12, 2016 Councillor Thompson met with representatives from the Alberta Energy Regulators, Pembina and Newalta.

Councillor Conlin

Councillor Conlin attended an Emergency Response Plan meeting with Council concerning the wild fire May 16, 2016 that was in a close proximity to the Town of Fox Creek. Councillor Conlin was at the Community Futures loan meeting where they approved a business loan for \$120,000.00 for a business in Edson as part of a joint venture with two other CF's. The total for this start up business was \$360,000.00.

Councillor Gervais

Councillor Gervais personally distributed Chevron's local hire contract business cards to multiple local businesses in Fox Creek.

On May 10, 2016 Councillor Gervais took Tristen Goodman and Scott Millar representatives of the AER on a tour of the Town of Fox Creek and area to point out firsthand the issues the Town is experiencing. On May 11, 2016 Councillor Gervais was in Little Smoky to attend part three of the meeting between Alberta Energy Regulator, MD of Greenview Council and Town of Fox Creek Council. Councillor Gervais reports that the Towns' concerns are being heard and many have already been addressed. The AER is looking into putting satellite metering units on all withdrawals used for fracking from ground water and wells. The AER's proximity to, presence within and ability to monitor the play in a timely and effective manner have also been satisfactorily resolved as well as many of the other issues that were brought forward.

Councillor Stadnyk

Councillor Stadnyk attended part three of the AER, MD of Greenview and Town of Fox Creek joint meeting in Little Smoky on May 11, 2016, and a portion of the meeting that took place in Fox Creek on May 10, 2016 with the MD of Greenview. On May 24, 2016 Councillor Stadnyk was present at the Skate Park meeting and told Council that if anyone was interested they can attend the Skate Park Design meeting on May 30, 2016.

Mayor Ahn

Mayor Ahn attended a meeting with the MD of Greenview on May 10, 2016 in Fox Creek. The meeting centered on the upcoming development of the Multi-use Facility, recreational areas in and around Fox Creek and proposed financial assistance. The MD had stated that they will be putting together an agreement for the Town that will cover 25% of recreation expenditures. Mayor Ahn will be attending a MD of Greenview Council meeting to present as a delegation. On May 11, 2016 Mayor Ahn met with the AER and the MD of Greenview for part three of the joint meeting. On Thursday May 12, 2016 Mayor Ahn attended a Heart River Housing meeting, to prepare for a meeting with the Minister of Housing.
