SemCAMS is currently in the middle of constructing a new Gas Plant near Grande Prairie, called the Wapiti Gas Plant.

There is a line already running from the new Gas Plant location to their existing plant (K3) in Fox Creek.

Their turnaround for their K3 plant will commence on May 23 and run until June 27, 2017.

SemCAMS continues to invest in the community focusing on Health, Education, wellness and community. They have recently invested in the walking/riding trail systems, playground equipment for the school, play school infrastructure and programs as well as the Christmas Hamper.

b) <u>Charette Pell Poscente Environmental Corp. – Wildfire Mitigation Strategy</u> Tyler Pell & Lindsay Dent

FireSmart Planning Standards follow the Guidebook for Community Protection.

Wildfire Risk and Hazard Assessment – the threats in the Fox Creek planning area are High to Extreme during the Spring and Fall, and can range from low to high in the summer.

The 5 of the highest urgency recommendations were discussed:

- Recommendation 5: The FireSmart Committee and the Town work with residents and industry to remove debris piles, and construction waste from yards or construction sites.
- Recommendation 7: The FireSmart Committee, the Town and the Alberta Agriculture and Forestry monitor and maintain completed vegetation management projects and complete the new recommended projects.
- Recommendation 8: Property owners maintain their properties by mowing and maintain grass, debris, and removing other combustible materials. Prune conifer trees to a height of 2 meters above the ground.
- Recommendation 9: The FireSmart Committee plans annual woody debris disposal service to assist residents with maintain private property – The Town already provides road side pick-up for any debris and backyard clippings and such.
- Recommendation 10: The FireSmart committee, Blue Ridge Lumber and Alberta Agriculture and Forestry work together to identify and harvest mature C2 stands of concern and reforest to D1 – Deciduous or M1 – Mix stands within the FireSmart Community Zone.
