Gord Ashmore and Ronica DeCiccio representing the Fox Creek for the Children Fundraising Society presented Council with a breakdown of the cost for the playground project and the specified monetary amount the society is requesting as a donation from the Town of Fox Creek. The society has raised \$50,850.00 through various fund raising events and money received through generous donations from nonprofit organizations that are located in the town of Fox Creek.

Fox Creek for the Children Fundraising Society has chosen the grades 4-6 playground as their first project but did inform Council that they already have a list of other undertakings that they will be moving forward with upon completion of the playground. The society goals are to fund raise for projects that the youth of Fox Creek are in need of.

The Society will be applying for the Community Facility Enhancement Program Grant that will match any funds that the Society has raised. The Society is requesting a donation from the town of Fox Creek in the amount of \$70,000.00, with this amount being donated the Society can move forward to apply for a matching grant of \$120,000.00 which will cover the cost of the playground project for grades 4-6 at the Fox Creek School.
